Advanced Diploma in Cosmetology

Details of the Certificate in Cosmetology programme has been elaborated below.

Certificate in Cosmetology is a 1 to 3 month long undergraduate level certificate programme in various aspects of makeup, hair care, skincare and nail care.

It is a hands on training course on doing stage makeup, hair styles, manicures and pedicures on clients for television, movies, stage etc.

Candidates need to be at least 10th or 12th pass out to be eligible to get admission into the programme.

The programme is more practical skills based learning which makes the curriculum more intense. Students are taught industry ready knowledge and skills to be employed right at graduation.

Candidates get to specialize in hair care and styling, nail care, manicure and pedicures, professional makeup, all types of beauty therapy etc.

What is the Certificate Advanced Diploma in Cosmetology Syllabus?

The syllabus and level of difficulty of the syllabus of the course will differ from the institute offering it. Most institutes offer the following topics as a part of their Certificate of Cosmetology programme.
